Hands-free Texting While Driving Would be Banned Under Bill

Bay Area Assemblyman Jim Frasier, (D-Oakley) wants to prohibit texting with hands-free mobile devices while driving. California already bars texting with a hand-held electronic device while driving but permits the practice with voice-activated devices. That legislation (AB 1536) passed last year and went into effect January 1, 2013.

Frasier's bill, Assembly Bill 313, would essentially ban all texting while driving by also outlawing voice-controlled devices. CASE is in support of this legislation, which is scheduled to be heard in committee March 15. Following are excerpts from the text of the bill providing the author's rationale:

- (a) Distracted driving is a dangerous epidemic on America's roadways. In 2011, more than 3,300 people were killed in crashes involving a distracted driver. Approximately 400,000 people were injured in motor vehicle crashes involving a distracted driver.
- (b) New research published in 2012 indicates that the increase in cognitive load and decrease in working memory when talking or texting while driving increases crash risk significantly.
- (c) Driving while using a cell phone reduces the amount of brain activity associated with driving by 37 percent.
- (d) Eleven percent of all drivers under 20 years of age involved in fatal crashes were reported as distracted at the time of the crash.
- (e) A vast majority of research suggests that there is no difference in the crash risk of hand-held or voice-operated devices. Furthermore, no study has determined that texting while driving
- (f) Drivers are four times more likely to crash while talking hands free on a phone, which is the same crash risk as driving with a blood alcohol content of 0.08.
- (g) Sending or receiving a text takes a driver's eyes from the road for an average of 4.6 seconds, which, at 60 miles per hour, is the equivalent of driving the length of a football field blind.
- (h) Text messaging while driving creates a crash risk of 8 to 23 times that of driving while not distracted.
- (i) Nine out of ten drivers support laws that ban texting.

Teen Driving Deaths Increasing

A report released in February by the Governors Highway Safety Association (GHSA) found an increase in fatalities among 16-and 17-year-old drivers after several years of declines in that age group. The report examined deaths of 16-and 17-year-old drivers through the first six months of 2011 and found an 11% increase over the same period in 2010 based on preliminary data supplied by all 50 states and the district of Columbia. Deaths of 16-year-olds rose 16% and 17-year-olds 7%, for an overall jump of 11%.

Twenty-three states increases in deaths of 16-and 17-year-olds, 19 had decreases, and there was no change in 8 states plus the district of Columbia. Most of the changes were small. In 2011, the highest numbers for the first six months



were in Texas (26), North Carolina (17), Florida (15), Illinois (12), Missouri (10), and Pennsylvania (10), all of these states showing increases compared with the first six months of 2010. California was one of the states with no change (7 fatalities in the first six months of both 2010 and 2011).

If this trend continued in the second half of 2011, it will mark a reversal of long-standing yearly declines in teen driver deaths, especially among 16-year-olds. Graduated driver licensing (GDL) systems, which began to be introduced in the mid-1990s, and adverse economic trends in recent years leading to fewer miles behind the wheel, are thought to be primarily responsible for the declines. Deaths reached historic lows in 2010: 158 deaths of 16-year-old drivers compared with 508 in pre GDL 1995; and 250 17-year-old driver deaths compared with 507 in 1995. These are much larger decreases than occurred in other age groups.

Deaths of 16-and 17-year-old drivers in 2011 are still relatively low, and it is not a surprise that the numbers may be stabilizing or increasing slightly. Positive effects based on GDL laws and law upgrades that went into effect between 1996 and 2010 are leveling off. In addition, economic conditions have improved. The economic downturn in 2008 and 2009 is thought to have contributed strongly to crash reductions by reducing travel, especially among teenagers and others with limited income. However, widespread further strengthening of state GDLs is still possible, and compliance with the rules can be improved. Increasing GDL effects in these ways, and finding effective ways outside of GDL to reduce teen crashes are important goals.

Electric Vehicles May Get Noisier

Electric cars, which have soundless engines, will need to make noises to let pedestrians know they're nearby under a NHTSA proposal released in January.

Sounds will need to be detectable when vehicles are traveling slower than 18 mph so electric and hybrid-electric cars can be heard by bicyclists and pedestrians. The cost per vehicle to add external speakers to quiet cars will be about \$35.

New California Motor Vehicle Laws for 2013

These new laws became effective (on January 1, 2013:

Driving Under the Influence—

AB 2020 (Pan)—The law no longer allows a person who has been arrested and is suspected of driving under the influence

(DUI) of drugs, the option of a urine test. Prior to this change, a person had the option of submitting either urine or blood to determine the drug content of their blood.



Charter-Party Carriers of Passengers: Beverages: Alcoholic Containers—AB 45 (Chesbro)—This new law prohibits underage drinking in charter-party carriers (limos, buses, etc.) and makes the carrier and driver responsible for communicating this to their passengers. The law also requires a designee, who is at least 25 years of age, to be present whenever there are passengers who are under 21 years of age on board the vehicle and alcohol is being transported. The designee shall be responsible for ensuring the rules are followed, and the safety of the underage passengers throughout the duration of the trip.

Electronic Wireless Communications—AB 1536 (Miller)—This law allows California drivers to use hands-free technology to talk and text while driving. This will require the use of a device that is specifically designed and configured to allow voice-operated and handsfree operation to dictate, send or listen to a text-based communication. The device is required to also be used in a voice-operated, hands-free manner to be in compliance with the law. ed. note: Legislation introduced this year in the Assembly (AB 313) would also outlaw voice-controlled devices for texting.

Financial Responsibility and Insurance —AB 1708 (Gatto)—Drivers will now have the option of providing proof of insurance or verification of financial responsibility on an electronic device (smartphone, tablet, etc.), when it is

requested by law enforcement.

Autonomous Vehicles—SB 1298 (Padilla)—This new law allows driverless cars to be operated on public roads for testing purposes, provided that each vehicle has a fully licensed and bonded operator in the driver's seat to take control if necessary. The bill also instructs the Department of Motor Vehicles to adopt regulations that govern the licensing, bonding, testing and operation of autonomous vehicle technology.

Driver License-AB 2189 (Cedillo)-

This law allows a driver's license applicant who provides satisfactory proof that his or her presence in the United States is authorized under federal law, but who is not eligible for a social security account number, to be eligible to receive an original driver's license if he or she meets all other qualifications for licensure.

Child Passenger Restraints—AB 1452

(Hill)—Hospitals, clinics, and birthing centers will now be required to provide and discuss contact information regarding child safety seat requirements, installation, and




inspection to parents and caregivers upon discharge of a child, if the child is less than eight years of age.
